1. Introduction

The Internet Corporation for Assigned Names and Numbers (ICANN) plays a central role in global internet governance, overseeing the Domain Name System (DNS) and related policy development. Within ICANN, the **Non-Commercial Users Constituency (NCUC)** represents the interests of individuals, academics, civil society, and non-commercial organizations.

To strengthen outreach and deepen stakeholder engagement, the NCUC EC proposes hosting a **Quarterly Webinar Series of all the NCUC 5 regions**. 2. Objectives

The NCUC Quarterly Webinars aim to:

Facilitate meaningful participation from civil society, academic institutions, and non-commercial individuals in NCUC work.

Showcase NCUC's role and its impact within ICANN and the broader internet governance ecosystem.

Share key updates on DNS policy, ICANN policy developments, and how NCUC contributes to a more inclusive internet.
4. **Grow Membership**
Highlight the value of joining NCUC and encourage participation from new regions and communities.

3. Format and Structure

3.1 Webinar Format (Virtual)

The webinars will be held **quarterly**, each with a thematic focus relevant to ongoing ICANN policy and internet governance discussions. Sessions will be:

- **70 minutes in duration**
- Hosted virtually with open registration
- Moderated by NCUC leadership, members, or any appointed expert agreed upon by the EC

3.2 Core Components

- **Thematic Presentations:** Topics aligned with current policy issues, proposed by NCUC members and approved by the Executive Committee.
- **Expert Speakers:** Representatives from ICANN, academia, civil society, and the broader technical community.
- **Interactive Segments:** Live Q&A, polls, and participant feedback to promote dialogue and collect insights.
- **Membership Segment:** Information on how to join NCUC, member benefits, and testimonials.

4. Target Audience

Geographic Scope

6. Expected Outcomes

1. **Increased Awareness** of NCUC contributions to ICANN and internet policy development.
2. **Expanded Global Membership**, especially from underrepresented areas.
