Dear Farzaneh,

thanks for sending us this travel support call. Please find below my application, where I tried to address all eligibility criteria specified on the NCUC website.

Name and affiliation: Tatiana Tropina, Max-Planck Institute for Foreign and International Criminal Law, participating in the NCUC in my individual capacity. I am living in Freiburg, Germany; but am a Russian passport holder.

I am a member of the NCUC from the last year and I did vote in the previous year's NCUC election.

I have been actively engaged in the work CCWP on Human Rights and Corporate Social Responsibility and CCWG-Accountability. I also joined the RDS PDP working group recently (not been active there yet, but the work just started).

My work at CCWG-accountability and CCWP on human rights is very likely to be advanced at the ICANN 55 for the following reasons.

At the CCWG-Accountability I have been engaged into the efforts to adopt a bylaw, which will make ICANN committed to respecting human rights within it's mission. The proposed bylaw requires significant amount of work to be done in the Work Stream 2 (WS2) of the accountability process. The current outcome of the bylaw proposal is not known yet, because the ICANN's board is suggesting to move all the human-rights related issues to the WS2. Concerning the fact that CCWG plans to discuss the WS2 activities at the ICANN 55 meeting, the advance of my human rights-related work in Morocco doesn't depend on the outcome of the bylaw discussion. In any case, the WS2 will consider the development of the framework of interpretation of the

commitment to respect human rights. Furthermore, I am a member of the subgroup 3 of the CCWP on Human rights, which is tasked to actively participate in the WS2 of CCWG and help in developing the framework of interpretation of the human rights commitment. This work will also get advanced in Morocco.

There are not so many people actively pushing for the human rights commitment at the CCWG-Accountability, and those of us who do have to engage themselves in every discussion because of the board's resistance and general controversy of this topic at the CCWG-accountability. So every person who is actively engaged can contribute a lot to the development of this work. I think this can also be considered as a good reason for me to apply for the travel funds. I also hope that my activity will be advanced more in general, not only in the context of my human rights related work. I am interested in many issues such as ICANN's interactions with LEA (where I see some dangerous trends), DNS abuse, and some others. I hope that the possibility to travel to the ICANN 55 meeting will allow me to get more engaged into the issues that are relevant to my area of expertise and where NCUC can benefit from my engagement.

I agree (and am willing) to participate in any NCUC, NCSG and GNSO meetings during ICANN 55 and write a post-trip blog post for the NCUC website. I have never received NCUC funding before.

Concerning my travel arrangements: I gladly accept the possibility for the reimbursement after the trip. My preliminary calculation of the costs: approx. 130 EUR airfare and approx. 600-something EUR hotel costs. I don't know the costs to and from the airport yet. I assume my final costs won't be higher than 1000 USD.

I saw that preferred dates of travel are 3-10 of March. Unfortunately, I have obligations to lecture on cybersecurity for judges in Budapest on 4th of March - I made this arrangement a long time ago and I can't reschedule this, so I will be able to arrive to Morocco on 5th of March only. Need to come back to Basel and fly from there.

So my travel dates are 5-10 of March. I hope it is still suitable.

Dear Farzaneh.

I trust this message reaches you well.

I would like to apply for travel support from the NCUC to aid in my active participation in ICANN 55. I estimate requiring US\$550 in support to cover my travel expenses from the United Kingdom.

I will begin by providing a brief background as to who I am, and will then address the selection criteria for travel support as published on your website. I will conclude with a short breakdown of what funding I would require to participate in ICANN 55.

Who I Am and What I Do:

I am a new member of the ICANN community, having participated in my first ICANN meeting in Dublin as part of the NextGen@ICANN program, and I acknowledge that I am likely less qualified than many others who have requested travel support to enable their participation in this coming meeting. Nonetheless, I believe I can make a meaningful contribution to the NCUC and I am looking for any opportunity to become more involved in your work.

While I cannot profess to speak for anyone but myself, I feel I represent a broad number of constituencies of internet users on the basis of my present and past geographical locations, age, sexual orientation, internet usage patterns, and experience (or lack thereof) with ICANN and the NCUC more specifically. I am also not paid to participate in internet governance activities, nor is there an employer interested in any outcomes I work towards.

I am an Australian citizen based in the United Kingdom. I hold no sentimental nationalism, having since my birth also lived in Argentina, Canada, and Indonesia. Accordingly, having lived in the Americas, Asia, Europe, and Oceania, I bring geographical diversity to the constituency and an understanding of how different issues can be framed in different locales.

I purchased my first domain name in 2004 and in my possession are seven domain names (five -.com, one -.nu, and one -.xyz). I use a third-party privacy protection service to cloak my contact details from appearing in WHOIS searches for two of these domain names.

Outside of ICANN, I am a member of the Youth Coalition on Internet Governance, I am a prolific respondent to public consultations run by the Directorate General for Communication Networks, Content and Technology of the European Commission on the future of European audiovisual media services, and I conduct policy research for the London-based Media Reform Coalition, among other nimble, future-focused organisations whose missions I am passionate about.

I am 25 years of age, identify as a member of the LGBT community, and hold a Master's degree from the London School of Economics.

Selection Criteria:

Voted in the previous year's NCUC election, if eligible at the time:

I applied to join the NCUC in October 2015 and my membership was confirmed that December. I was therefore ineligible to vote in your last election.

Since joining the NCUC I have made an effort to involve myself in your activities and to educate myself on the agenda setting and decision-making processes utilised within the constituency. I have also spoken off-list with more active members to understand what issues are being tackled and what topics I need to read up on.

Are actively and verifiably engaged in NCUC's work, for example constituency governance, NCUC/NCSG policy discussions, or GNSO or cross-community working groups;

I have joined two working groups as a member: the Next-Generation gTLD Registration Directory Service Policy Development Process Working Group (RDS PDP WG), and the New gTLD Subsequent Procedures Policy Development Process Working Group (New gTLD PDP WG). While both working groups are in their infancy at this time, I have dialled into all scheduled conference calls and have been contributing to mailing list conversations where I have something of value to add.

Need to be at a given meeting because the above mentioned work will be advanced there;

I would like to attend ICANN 55 because both the RDS PDP WG and New gTLD PDP WG will meet for the first time. Both of these working groups are dealing with topics which sit at the centre of ICANN's mission and existence, and touch upon issues which are of key importance to non-commercial stakeholders. I would like to become more involved in these discussions. I would also find it beneficial meeting these stakeholders in person and putting a face to a name.

Agree to participate in any NCUC, NCSG and GNSO meetings held during the meeting;

Absolutely. Provided there are no scheduling conflicts, I would gladly commit to attending all NCUC, NCSG and GNSO meetings.

Agree to write a brief post-trip blog post for the NCUC website reflecting on the meeting's main developments of relevance to NCUC;

It would be my pleasure to do so. I wrote about my experiences attending ICANN 54 for the LSE Media Policy Project. You can read my blog post here:

Did not receive NCUC funding to attend the immediately previous ICANN meeting, unless exceptional circumstances require their presence at two consecutive meetings. (Note: this criteria only applies to regular ICANN meetings, as below)

I have not previously received funding from the NCUC.

Agree to make their own travel, accommodation, visa, and related arrangements and be reimbursed after the trip. NCUC cannot provide funds in advance of meetings or any administrative support.

I can comply with this condition.

Travel Support Required:

I anticipate being in Marrakech from 6 March to 11 March. Aside from allowing me to attend all NCUC, NCSG and GNSO meetings (provided there are no scheduling conflicts), this will allow me to participate fully in the public board meeting on the evening of 10 March, and I have been advised by Susan Kawaguchi, acting chair of the RDS PDP WG, that this will enable me to participate fully in the working group's meetings tentatively scheduled for 8 March. I am seeking travel support of up to US\$550, covering my flight from London (\$100) and accommodation (\$450). I will meet any additional expenses incurred.

I would like to finish my thanking the NCUC and its donors for making travel support available for members to participate in ICANN meetings. I am also very grateful to the Executive Committee for taking the time to consider my request.
