Dear Farzaneh,

Please find below my application for travel support for ICANN58:

- 1. I would like to apply as a mentor. I have been working in the ICANN space for a year and a half, and have attended the past 4 meetings. I have also been closely involved with NCUC during this time. I have started to feel comfortable in the space and the areas in which I have been working. However, I was a newcomer not so long ago, and remember all too well the difficulties one faces initially. I believe that this will help me guide newcomers in identifying working groups and processes to get involved in.
- 2. I have been an active participant in CCWG-Accountability since ICANN54, and have found the face-to-face meeting held on day 0 to be most useful for furthering discussions. The crux of my work has been in the nature of capacity building, by simplifying complex discussions so that they are useful for those not following the process as closely. Some of this work has also been published on the NCUC blog.

CCWG-Accountability is a fascinating case study for understanding multistakeholder participation in ICANN, which is another area I have been working on. This requires an understanding of the dynamics between and among the stakeholders, and whether this has changed since the IANA transition. This requires me to be present for the meetings. I have also been regularly involved in submitting public comments for this process.

I am also a member of the WHOIS PDP. I have been closely observing the discussions over the past 7-8 months. I look forward to this meeting to take on a more active role in the working group. I have been working on WHOIS-related issues for the CCWP-HR as well, encouraging a closer examination of the privacy and other human rights implications of WHOIS, a position that needs to be pushed more in the WHOIS PDP WG as well.

It is important for me to attend ICANN58 to further my work in the above mentioned working groups, as well as get involved in more work. I look forward to becoming more involved in CCWG-IG work as well, with the aim of broadening my focus area. I will also be participating in all NCUC sessions during the week.
